## Show flats open in completed towers

PARK YOHO Milano has modified show flats with furniture and fittings, plus unmodified show flats available for viewing. The Milano Manor<sup>8</sup>, modified show flat<sup>7</sup> of Unit A on 10th floor of Tower 36A, features large three-bedroom (one en-suite) with an attached living-dining space that connects to a 31-square-foot balcony, helping to enhance the sense of space.
