# Twin Regency – Hotel-style residential development for young buyers

## **Practical layouts**

The clubhouse Club Regency¹ will be located on the ground floor and first floor of Tower 1 with a total area of over 17,000 square feet (including the greenery). The clubhouse will feature more than 20 facilities, including a 25m outdoor swimming pool, outdoor jacuzzi, aerial yoga room, a 24-hour gym, reading room and function room. 47 parking lots will be available on the ground floor and basement. The two 21-storey residential blocks will offer a total of 523 units, mostly studios and one-bedroom units. There will also be two-bedroom and special units with diverse layouts to choose from.
