The project is located in Tuen Mun, where it is a strategic core of the billions of investment in infrastructure. It is connected in the north to the Hong Kong-Shenzhen Western Corridor<sup>2</sup> and S3 Guangshen Yanjiang Expressway<sup>3</sup> which goes to Qianhai, Shenzhen and Shenzhen Bao'an Airport. In its south, the Tuen Mun-Chek Lap Kok Link<sup>4</sup> and the Hong Kong-Zhuhai-Macao Bridge<sup>5</sup> directly head to the Hong Kong International Airport and Hengqin, Zhuhai. It is very convenient to travel from Tuen Mun to Central, Admiralty and other commercial areas via MTR West Rail Line. With the completion of major infrastructure projects, Tuen Mun will become the heart of Hong Kong-Shenzhen–Macao, which will bring extra potential to Eight Regency.

Eight Regency is conveniently located within the comprehensive transportation network and that it is in close proximity to Kin Sang Light Rail Stop connecting to MTR network and it is easily accessible to the central business districts in Hong Kong and Kowloon from bus terminal and shuttle bus stop close-by. In addition, several green minibus routes nearby reach Lok Ma Chau and Sheung Shui directly. Eight Regency enjoys extensive and greenish view of Tsing Tin Playground, and it is next to several shopping centres with F&B outlets, supermarkets and houseware stores, etc, while retail shops in the podium cater to the residents' daily needs. Since Kin Sang district has lacked a new supply of private homes for years<sup>6</sup>, Eight Regency will inject new vitality into the residential property market in that area and attract the attention of buyers.
